Joseph M. Rubino is one the nation's premier transit industry leaders, having worked on projects involving ground passenger transportation in 47 states. Mr. Rubino's career has now spanned more than 5 decades, 1st as an executive and now as an industry consultant, expert witness, and prolific author of more than 600 peer-reviewed columns, articles, and studies. He not only has great expertise in transit operations, business development, and regulatory issues, but he is also a renowned industry spokesperson. He has made more than 400 industry speeches and presentations in 33 states, many of which were done under contract with the federal government.

**His expertise in passenger ground transportation includes:**

**Industry Pioneer-** Mr. Rubino has played a major role in the modernization of the for-hire industry and his career has been marked by a series of FIRSTS.

- **1974-** Mr. Rubino's company in Miami, FL, Metro Transportation Services, created the first de facto Non-Emergency Medical Transportation service (NEMT). In 1976, Mr. Rubino became the General Manager of that service.
- **1974-** Metro created the first Paratransit Service in the United States as a pilot program called the Miami-Dade County Special Transportation Service (STS). In 1976, STS was formalized as a contracted service, and Mr. Rubino was named General Manager of that service.
- **1976-** Mr. Rubino created the country's 1st written, comprehensive, for-hire driver training program. Prior to this, training in the USA for for-hire drivers was generally conducted orally by peer to peer drivers who worked without an outline or script. Mr. Rubino created the 1st classroom-style driver training program featuring a comprehensive, all-inclusive, training syllabus which included driver training videos, a driver training manual & multiple presenters.
- **1976-** Mr. Rubino created the nation's 1st for hire driver training video. A former broadcast journalist, Mr. Rubino wrote, directed, narrated, and edited the video himself.
- **1978-** Mr. Rubino and his team deployed the first Braun wheelchair-lift vehicle in the United States utilized by a private company for commercial purposes. Prior to 1978, Mr. Braun's wheelchair-lifts were only owned and used by private individuals in their own vehicles for their own use.
- **1979-** Mr. Rubino and his team were the first private for-hire transportation in the United States to deploy computerized passenger trip-scheduling and vehicle-routing.
- **1979-** Mr. Rubino created the first non-governmental MicroTransit service called HealthTrans which was designed to transport hospital patients to and from their appointments. The HealthTrans MicroTransit program served 27 hospitals and medical centers over a 4 County area of South Florida from 1979-2002.
- **1983-** Mr. Rubino and his company were awarded the nation's first FTA 5310 Grant vehicles operated by a for-profit fleet. Prior to this, all 5310 Grant vehicles in the USA were operated only by non-profits or transit agencies.

**Expert Witness-** Mr. Rubino has served as an expert witness 460+ times since 2008 and, during this time, his case portfolio has consistently been split at approximately 50%-50% for Plaintiff/Defense work. He does not advertise and most of his work is from repeat clients.

Prior to opening his own firm, Mr. Rubino was identified by his former employer, Metro Transportation Services of Miami, Florida, more than 50 times in legal matters as his company's Corporate Representative. Combined with his work as a Corporate Rep he has worked on legal matters more than 500 times, has been deposed more than 130 times, and has testified in court more than 30 times. He has opined on 200+ cases involving elderly or disabled riders, 180+ cases involving medical transportation, 50+ cases involving bus services, 20+ cases involving delivery services such as Uber Eats, DoorDash, GrubHub, Amazon, Wal-Mart and 110+ cases involving TNC/Rideshare services like Uber and Lyft.

He spent 28 years at Metro Transportation in Miami, FL, managing a 750 vehicle fleet, including some 350 wheelchair accessible vehicles. ***Metro's fleet transported more than 10,000 wheelchair passengers per week for more than 20 years for a total of more than 10 MILLION wheelchair riders transported during that period of time.***
